

- **Pay Loss issue of SRD JTO 2011 batch:** JTOs recruited for vacancy year 2011 through special recruitment drive are offered initial basic pay of Rs. 16400/- as was earlier offered to JTOs of recruitment year 2008. But after corporate office order No. 1-29/2010- PAT (BSNL) dated 3-Jan-2012 & 19-Mar-2012, JTOs of batch 2007/2008 & JAOs batch 2010 were given five additional increments over E1 scale to protect the pay loss. On similar ground, it is humbly requested to allow JTOs of SRD batch year 2011 to draw E1 + 5 increments i.e. Rs. 19020/- to avoid discrimination in a same cadre.

Your personal intervention is highly solicited to redress the above issues please.

Minutes of the meeting held on 04.04.2012 with AIGETOA, Punjab

A meeting was held with AIGETOA Punjab Chapter under the chairmanship of CGMT in which the following decision were taken :

1. It was decided to process all the pending inter-circle couple cases without any condition of 5 years. It was further decided to process three inter-circle transfer requests every month. The decision will be reviewed after six months.
2. It was agreed to issue modified appointment orders w.e.f. the date of successful completing of field training in case of those JTOs who had not been relieved after completion of field training and whose PVR were received on a later date. SSA Heads will forward such cases.
3. Regarding reimbursement of higher studies according to the prevalent guidelines in force at the time of submission of case, it was agreed that the case would again be taken up with BSNL Corporate office.
4. Regarding fixing of seniority of DR JTOs viz-a-viz promotee JTOs. It was decided that the representation of the association may be again sent to AGM(HR) of this office for onward submission to BSNL Corporate Office. Association to give representation in this regard.
