The issues are still pending despite your positive assurance to resolve the issues in many meetings. Despite our efforts to engage in constructive dialogue but no response and lack of actions on any of the issues, has left us with no choice. We have exhausted all the avenues of recourse and yet the issues remain unresolved. Therefore, we have no options left but to take the streets and demand actions.

Considering the non-seriousness of Circle management, Association is duty bound to take hard steps for the resolution of issues. Accordingly, we hereby serve the notice for a lunch hour demonstration across Punjab Circle followed by One day Mass dharna (if demands are not fulfilled in due course of time) to seek the attention of the management.

**Demands:**

1. Immediate Transfer of our District Secretaries to BA HQ as per REA guidelines issued by the BSNL CO.
2. Execution of request transfers i.e. OTP cases in Accounts Cadre.
3. Rotational transfers from rural to urban areas in Amritsar BA.
4. Discrepancy in Intra Circle rotational transfer list.
5. Immediate attention to increase the number of empaneled hospitals in each BA/OA's.
6. Proper working environment for staff i.e. AC, Table Chairs and water cooler, Desktop and Laptop etc.
7. Immediate Attention on FTTH Services along with Provisioning.
