Date, Time and venue of Election of Circle body: 22nd Nov 2020 -from 02:00 PM onwards ON LINE mode. Declaration of result: On 22nd Nov 2020 (as and when election procedures completes)

Manner in which election will be conducted:

- Online nominations for post of (CP / CS / CFS / 6ACSs / 2CVPs) will be invited through our website www.aigetoapb.weebly.com for new governing body from 17/10/2020 to 27/10/2020. Any valid member can file the nomination.
- 2. The provisional list of nominations for the election of new governing body of AIGETOA PB will be displayed on 29/10/2020.
- 3. Nominations can be withdrawn by 03.11.2020 by writing mail to RO (<u>ersharmag@gmail.com</u>) only.
- 4. Final nominations received will be displayed at www.aigetoapb.weebly.com by 05.11.2020.
- 5. Sequence of election will be decided by returning officer in consultation with district collegium and decision of returning officer will be final in this context.
- 6. Any person from the final list of nominations received can contest for any post in governing body as per provision and in adherence of the constitution of AIGETOA. If one can't be elected for one post can contest for next post.
- 7. Voting of election of circle bearers will be done by the electoral collegium as per provision of constitution through online mode.

8. Any objection on the list of collegium of the society entitled to vote or members to be elected as governing body of AIGETOA Punjab shall be decided by the returning officer in consultation with the office bearers of the society. However the decision of the returning officer shall be final in the event of any difference of opinion.

9. List of collegium members (one per four members) will be decided by district bodies. District body will send the name of collegium members by 22.10.2020.
