Subject: BSNL Board approval on revised sanctioned strength post VRS restructuring in Civil Stream and the modifications in the Recruitment Policy-Reg

Approval of BSNL Board is hereby conveyed on Manpower requirement and modifications in Recruitment Rule post VRS restructuring, in respect of Civil Stream, as under:

- 1. The revised Sanctioned strength post VRS shall be effective w.e.f. 01.02.2020. All the post of Executives who have taken VRS are abolished w.e.f. 01.02.2020. The post held by the Executives retiring on superannuation from 01.02.2020 to 31.01.2022 shall be considered as personal and supernumeric in terms of the decision of cabinet conveyed vide DoT letter dated 05.01.2021 (the post held by employees in the age of 58-60 Years will lapse as and when such employees retires during the period from 01.02.2020 to 31.01.2022).
- 2. After taking into consideration the abolition of post as per para 1 above, the approved man power in different grades in respect of Executives of Civil Stream is as under -

- 3. All the posts in excess of the approved sanctioned strength Post VRS restructuring by BSNL Board in different grades and streams stand abolished w.e.f. 01.02.20.
- 4. The revised sanctioned man power post VRS in all Territorial, Non- Territorial Circles, Corporate office in respect of Executives of Civil stream upto AGM Grade is enclosed as **Annexure-I**.
- 5. Norms for operational functions for SE/ EE/SDE& JTO in the field in Civil streams and their reporting are as under-

- a. The location of SE and EE which have been considered in the circle structure and for operational works at different locations are enclosed as **Annexure-II**.
- b. Locations of SDE/JTO for operational work will be issued by concern cadre controlling authority i.e. CGM (BW) based on work load and copy of list shall be sent to Restructuring unit BSNL CO, for records.
- c. As the presence of civil executives are required at Project site. So, depending upon the workload at a geographical location for project execution or maintenance work or for Asset monetization, the location of SE, EE, SDE/JTO can be changed by the cadre controlling authority i.e. CGM(BW), based on business requirement of BSNL, within the overall grade strength and with the approval of Director- HR.
- d. Presently there is dual reporting system in respect of executives of civil stream based on earlier organizational structure in BSNL. Since the Organisational Structure has been revised and SSA concept no longer exist, so a revised reporting structure shall be issued by concern cadre controlling authority i.e. CGM (BW) in line with modified Organsational Structure and a copy shall be sent to Restructuring Unit for records.

- 6. Following modifications are approved in the Recruitment Rule of Executives of Civil Stream are as under:
  - a) Direct Recruitment in JTO and MT shall be continued in Executive Grade in Civil Stream.
  - b) Number of MT Management Trainee post considered for Civil Stream is 27 with Internal and External provision 50:50 i.e. 50% of total post (14) for Internal and 50% of total post (13) for external. Further the internal provisions have been converted into LICE for promotion from SDE to EE grade. Accordingly, these provisions may be added or modified in the MTRR and MSRR of civil stream.
  - c) Under Organisational Restructuring, in the new structure and norms of all planning and field units, JTO/JAO or eq. and SDE/AO or eq. are functionally considered in single cluster (interchangeably used) i.e. JTO or eq. and SDE or eq. shall work independently and both shall report to next higher level. Further due to various reasons, the promotion from JTO or eq. to SDE or eq. are delayed and the Executives are stagnating at JTO or eq. level for more than 15 to 20 years. So considering the HR best practices and uniformity in policy across all the streams, a JTO with 12 Years service in JTO grade, as 1<sup>st</sup> January of the Financial year, may be considered for on Promotion from JTO to SDE on personal up gradation basis. Subsequently on vacating the post of SDE either by promotion to next higher grade or by superannuation/VRS/ Technical resignation/ resignation, the post of SDE will be reverted back in JTO grade. Accordingly, the RR of SDE may be modified.
  - d) The number of GM and above grade executives working in civil streams are more than the numbers fixed under post VRS sanctioned strength. These executives shall be used on the common management post like HR/Admin/S&M/EB and BA head etc.
  - e) No increment shall be allowed on post based promotion from GM/ Sr. GM to PGM/CGM posts.
  - f) No Direct recruitment will be made in future without the approval of the BSNL Board. So, Direct Recruitment in the JTO/MT arising in a year due to vacancies in the Grade shall be made after analysing the actual requirement in the field and with the approval of BSNL Board only.
