The transfer is subject to the following conditions that :-

1. They will not claim any TA/DA/Joining Time.
2. They unconditionally agrees to accept the seniority in the gradation list of the new circle as laid down in Rule-8 of BSNL's Employees Transfer Policy.
3. They will not seek re-transfer to parent circle before completion of 5 years of service in the new Circle.
4. They accepts that claim for the benefit of promotion on having qualified in the departmental examination while working in the parent unit, shall be permitted subject to the condition that a request to this effect is made by him within a period of six months of declaration of the result or finding a place in the select panel.

5. They accepts to forego all his claims in the old unit even if a permanent vacancy was available or becomes available because of the retrospective permanency of post or for any other reason he was entitled for confirmation against such post in his old unit/SSA.
6. They have never before availed of any chance of transfer/ mutual exchange within preceding five years.
7. They agrees not to claim for a posting in any particular station of the new Circle.
8. They accept all the terms and conditions as laid down in the BSNL's Employees Transfer Policy notified vide letter No. 6-1/2007-Restg. Dated 7-5-2008 and as amended from time to time.
9. They will rank junior most in the gradation list of the new circle to all the JTOs of that circle on the date of joining in the new circle, including all persons who have been approved for appointment to that grade on that date.
10. There should not be any Vig./Disc. case pending or being contemplated against the officer.
